At the end of the course, the student must be able to prove that he/she has acquired the following learning outcomes:

- R1 To acquire knowledge and handle historical and general issues: from the Treaty of Rome to the Treaty of Lisbon.

- R3 To acquire knowledge on the institutional system of the European Communities. To be able to differentiate the competences of the institutions.
- R4 To acquire knowledge of the main European institutions and the institutional system, their competences and the differentiation of the institutions: Commission, Council, European Parliament, Court of Justice, Court of Auditors Committee of the Regions.

Observations

1st) It is essential to obtain a minimum of 5 out of 10 in the exam to be able to compute or evaluate the other two evaluation instruments (on the one hand, "attendance, active participation and favorable attitude in the subject" and, on the other hand, "tests practices ") in 1st call. In 2nd call, only the exam grade will be taken into account, not taking into account the practices delivered, the practical tests or questionnaires carried out in the classroom or, in principle, the attendance and participation of the student throughout the semester.

2nd) In relation to the concept of "attendance, active participation and favorable attitude in the subject" (15%), the mere attendance or physical presence at the classes will compute a maximum of 5%, while the remaining 10% will derive from the favorable attitude in the subject shown in one of the following ways:

- 1-The interventions of the students in the classes themselves (in person or online), with the corresponding records or annotations.
- 2-Virtual tutorials through the UCVnet virtual Campus or online sessions through Teams developed as a group or individual tutorial.
- 3-The interventions in the forum created on the UCVnet platform to raise and answer questions on the agenda.
- 4-Emails or messages received raising questions about the subject matter.

3rd) Only if the final grade is equal to or greater than 5, the subject will be approved. This both in 1st and 2nd call. However, if the student obtains a total mark close to the one approved in the 2nd call, he may pass the subject if the teacher considers it correct, taking into account the outstanding interventions of the student in question throughout the semester.

According to article 9 of the General Regulations for the Evaluation and Qualification of Official Teachings and Own Degrees of the UCV, the continuous evaluation system is the preferred evaluation system at the UCV. The art. 10 allows, however, for those students who, in a justified and accredited manner, express their inability to attend in person (or to synchronous communication activities for virtual and/or hybrid teaching modalities), their



evaluation on an extraordinary basis in the so-called single evaluation. Said single evaluation must be requested within the first month of each semester to the Dean of Faculty through the Vice-Deaneries or Master's Directorates, with the express decision on the admission of said request from the student concerned being the responsibility of the latter.

The evidence to be presented and/or the test/s to be carried out in the single evaluation by the student will be the same as for the rest of the students, although the percentages awarded to the different evaluation instruments will be the following: 50% practical tests and 50% theoretical written tests.

CLASS ATTENDANCE IN FACE-TO-FACE DEGREES

In accordance with the development guidelines of the General Regulations for the Evaluation and Qualification of Official Teachings and Own Degrees of the UCV, in face-to-face degrees, class attendance with a minimum of 80% of the sessions of each subject will be required as a requirement to be evaluated. This means that, if a student does not attend the sessions of each subject, in a percentage greater than 20%, he/she will not be able to be evaluated, neither in the first nor in the second call, unless the person responsible for the subject, with the approval of the person responsible for degree, in view of duly justified exceptional circumstances, exempt from the minimum attendance percentage. The same criterion will be applicable for hybrid or virtual degrees in which teachers must maintain the same percentage in the requirement of "presence" in the different training activities, if any, even if these are carried out in virtual environments.

MENTION OF DISTINCTION:

The mention of "Honors" may be awarded to students who have obtained a grade equal to or greater than 9.0. Their number may not exceed five percent of the students enrolled in a group in the corresponding academic year, unless the number of students enrolled is lower.

Learning activities

The following methodologies will be used so that the students can achieve the learning outcomes of the subject:

- M1 Group work sessions supervised by the teacher. Study of legal cases, both true and fictitious. Significant construction of knowledge through student interaction and activity. Critical analysis of values and social commitment.
- M6 The student must present a case in which the applicable law is not the national law but the Community or international law directly.
- M7 The students must read some specific texts that are connected with the module and be able to present their conclusions.



- M8 Exposition of contents by the teacher, analysis of competences, explanation and demonstration of capacities, skills and knowledge in the classroom.
- M11 Personalised attention and in small groups. Period of instruction and/or orientation carried out by a tutor with the aim of reviewing and discussing the materials and topics presented in the classes, seminars, readings, completion of assignments, etc.
- M12 Set of written and/or oral tests used in the initial, formative or summative evaluation of the student.
- M13 Group preparation of readings, essays, resolution of problems, seminars, papers, dossiers, etc., to be presented or delivered in theory classes, practical classes, and/or small group tutorials.
- M14 Student's study: individual preparation of readings, essays, problem-solving, seminars, works, reports, etc. to present or deliver in the theoretical classes, practical classes and/or small group tutorials.
