#### **Observations**

#### **ATTENDANCE**

Not attending 75% of the classes supposes the loss of the right to take the exam in the first call, having to attend the second call directly. Since the student can miss 25% of the total classes, excuses for absence will not be accepted, except in the case of extraordinary circumstances and the percentage of 25% has been exceeded. In no case will the justifications sent by email, virtual tutoring or message on the platform be taken into account. Lack of punctuality when starting the class may be considered as "absence" attendance, once the attendance control -oral or by signature- by the teacher has passed.

Criteria for students who prove the impossibility of regularly attending class for justified reasons: Students who, due to work, health or any other duly accredited circumstance, cannot regularly attend class, must contact the subject teacher during the first two weeks of the semester. This will offer them an alternative itinerary for the acquisition of the necessary skills to pass the course.

**EVALUATION**. Assessment. To pass the subject it is necessary to pass the written test; only then will the percentage corresponding to group work and attendance-participation be added. The delivery of tasks after the deadline and time established on the platform is not allowed. In no case will those that are sent by email, virtual tutoring or message on the platform be evaluable. **Criteria for granting honors**: Honors may be awarded to the best students, who must have obtained a minimum grade of 10 (provided that the student has stood out significantly in monitoring and taking advantage of the subject). If circumstances require it, a special test may be established to determine those students deserving of honors, taking into account the limitation of 5% of enrolled students. In the second and subsequent calls, only the honors that may remain after the first call may be awarded.

In accordance with the regulations governing the assessment and grading of subjects in force at UCV, the distinction of "Matrícula de Honor" (Honours with Distinction) may be awarded to students who have achieved a grade of 9.0 or higher. The number of "Matrículas de Honor" (Honours with Distinction) may not exceed five percent of the students enrolled in the group for the corresponding academic year, unless the number of enrolled students is fewer than 20, in which case a single "Matrícula de Honor" (Honours with Distinction) may be awarded.

Exceptionally, these distinctions may be assigned globally across different groups of the same subject. Nevertheless, the total number of distinctions awarded will be the same as if they were assigned by group, but they may be distributed among all students based on a common criterion, regardless of the group to which they belong. The criteria for awarding "Matrícula de Honor" (Honours with Distinction) will be determined according to the guidelines stipulated by the professor responsible for the course, as detailed in the "Observations" section of the evaluation system in the course guide.
