Recommended knowledge



The subject investigates the theoretical and empirical psychosocial bases of social intervention. It is an eminently practical and methodological subject, and is focused on the design, implementation, evaluation and monitoring of programs and projects aimed at both discriminated, excluded or marginalized collectives and social groups, as well as normalized and integrated collectives and social groups.

This optional subject assumes the frame of reference that the Official College of Psychologists of Spain establishes for those professionals who work in the Area of Social Intervention Psychology (<http://www.cop.es/perfiles/content/is.htm>). Here the student will be immersed in the contents, theories, strategies, models and tools of intervention in the Psychology of Social and Community Intervention. The Psychology of Social and Community Intervention is one of the branches of Social Psychology that arises in response to the need to analyze and act on psychosocial problems from different levels of intervention: individual, interactive and interpersonal context, situational and macrosocial level. . No prior knowledge (theoretical or instrumental) is required, but it is recommended that students are sensitized and aware of social problems and are predisposed to get involved in social development, community intervention and citizen empowerment. It is also convenient for students to show their commitment to solidarity with social groups in difficulty and excluded and with their social integration and personal and community development.

Observations

The practical activities will be evaluated from the submissions requested by the teacher and which will be included in the student's portfolio. All deliveries will be made in the virtual classroom, according to the tasks created for this purpose. Class attendance and active participation in the activities and dynamics developed in the classroom will be assessed through rubrics and follow-up lists, with 20% of the final grade obtained by the student.

In case of absence and in second calls, students will develop exercises and complementary practical activities proposed by the teacher.

REGISTRATION OF HONOR As a sign of academic exceptionality and according to the critical judgment of the teacher based on the grades obtained by the students and taking into account the participation, involvement and responsibility shown by them, adjusting to the pertinent regulatory framework, the teacher may distinguish those students who have obtained global qualifications higher than 9.50 points.

In accordance with the regulations governing the assessment and grading of subjects in force at UCV, the distinction of "Matrícula de Honor" (Honours with Distinction) may be awarded to students who have achieved a grade of 9.0 or higher. The number of "Matrículas de Honor" (Honours with Distinction) may not exceed five percent of the students enrolled in the group for the corresponding academic year, unless the number of enrolled students is fewer than 20, in which case a single "Matrícula de Honor" (Honours with Distinction) may be awarded.

Exceptionally, these distinctions may be assigned globally across different groups of the same subject. Nevertheless, the total number of distinctions awarded will be the same as if they were assigned by group, but they may be distributed among all students based on a common criterion, regardless of the group to which they belong. The criteria for awarding "Matrícula de Honor" (Honours with Distinction) will be determined according to the guidelines stipulated by the professor responsible for the course, as detailed in the "Observations" section of the evaluation system in the course guide.

Learning activities

The following methodologies will be used so that the students can achieve the learning outcomes of the subject:

- M1 Teacher presentation of contents, competency analysis, explanation and demonstration of capacities, abilities and knowledge in the classroom (presential modality).



- M2 Teacher-supervised groupwork sessions: case studies, diagnostic tests, problems, fieldwork, IT room, visits, data searches, libraries, web, Internet, etc. Building knowledge significantly through interaction and student activities (presential modality).
- M3 Supervised monographic sessions with shared participation.
- M4 Application of interdisciplinary knowledge.
- M6 Personalized attention in small groups. Training and/or orientation period by a teacher aimed at revising and discussing the materials and topics presented in the lessons, seminars, lectures, assignments, etc.
- M7 Set of oral and/or written tests employed in initial, training or summative assessment of the student.
- M8 Group preparation of readings, essays, problem resolution, seminars, assignments, reports, etc. to be presented or handed in during theory lessons, practical lessons and/or tutoring sessions in small groups. Tasks done on the platform or other virtual spaces.
