#### **EVALUATION CRITERIA**

- ·To pass the course the student must pass the different evaluation systems separately.
- •The evaluation of the course will involve a compendium of evidence of attendance to the informative sessions, the evaluation of the student's performance during the practical stay by the tutor of the internship center, as well as the evaluation of the written report.

#### CRITERIA FOR THE AWARDING OF HONORABLE MENTION:

•The mention of Matrícula de Honor may be awarded to students who have obtained a grade equal to or higher than 9.5 and evidence levels of excellence in the performance of the practical stay, as well as in the attendance to the informative sessions and the written report. In accordance with the general regulations, only one honorary matriculation may be awarded for every 20 students, not per fraction of 20, with the exception of groups of less than 20 students in total, in which one matriculation may be awarded.

In accordance with the regulations governing the assessment and grading of subjects in force at UCV, the distinction of "Matrícula de Honor" (Honours with Distinction) may be awarded to students who have achieved a grade of 9.0 or higher. The number of "Matrículas de Honor" (Honours with Distinction) may not exceed five percent of the students enrolled in the group for the corresponding academic year, unless the number of enrolled students is fewer than 20, in which case a single "Matrícula de Honor" (Honours with Distinction) may be awarded.

Exceptionally, these distinctions may be assigned globally across different groups of the same subject. Nevertheless, the total number of distinctions awarded will be the same as if they were assigned by group, but they may be distributed among all students based on a common criterion, regardless of the group to which they belong. The criteria for awarding "Matrícula de Honor" (Honours with Distinction) will be determined according to the guidelines stipulated by the professor responsible for the course, as detailed in the "Observations" section of the evaluation system in the course guide.

### Learning activities
